#### What is the purpose of this update?

#### Description of this fund

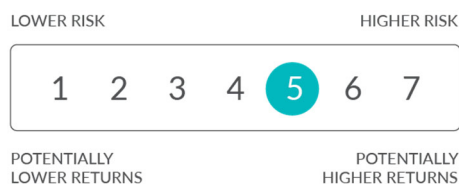
The Listed Property Fund mostly invests in listed financial products issued by entities whose principal business involves the owning or managing of property, property-like assets or real assets, aiming to achieve positive long-term returns.

#### What are the risks of investing?

Risk indicator for the Listed Property Fund:

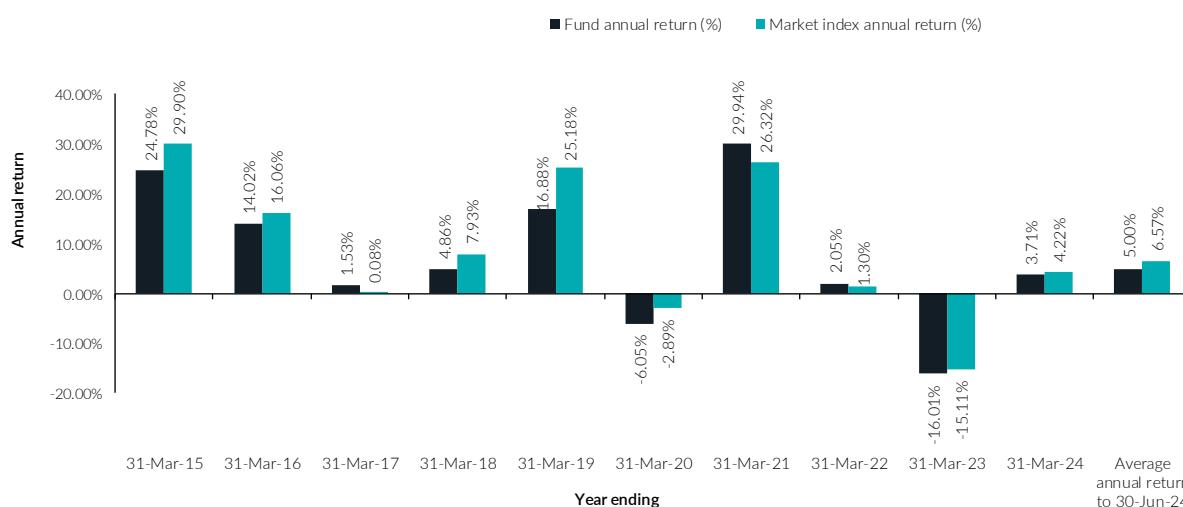

#### How has the fund performed?

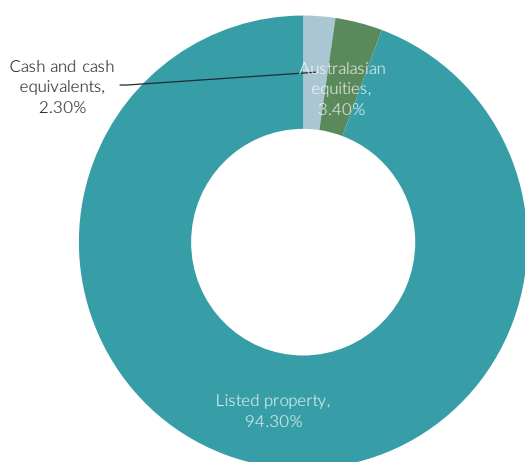
### Example of how this applies to an investor

Jane had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane incurred a loss after fund charges were deducted but before tax of \$792 (that is -7.92% of her initial \$10,000). This gives Jane a total loss after tax of \$830 for the year.

The top 10 investments make up 89.02% of the fund.

We actively manage the fund's foreign currency exposures. As at 30 June 2024, these exposures represented 4.96% of the value of the fund. After allowing for foreign currency hedges in place, 3.25% of the value of the fund was unhedged and exposed to foreign currency risk.
