What is the purpose of this update?

This document tells you how the New Zealand Fixed Interest Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The New Zealand Fixed Interest Fund invests in New Zealand fixed interest assets. It aims to achieve long-term returns (before fees, taxes and other expenses) greater than the Bloomberg NZBond Composite 0+ Yr Index.

## What are the risks of investing?




Small differences in fees and charges can have a big impact on your investment over the long term.

#### Example of how this applies to an investor

Jane had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted but before tax of \$594 (that is 5.94% of her initial \$10,000). This gives Jane a total return after tax of \$428 for the year.
