What is the purpose of this update?

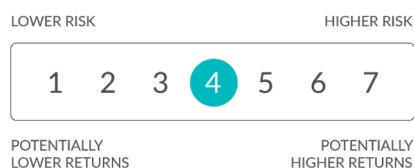
Description of this fund

The Growth Fund invests across multiple asset classes, selecting a lesser exposure to cash and fixed interest investments and a greater exposure to equity and property investments. Investors can expect moderate to high levels of movement up and down in value. It aims to achieve long-term returns (before fees, taxes and other expenses) greater than a composite benchmark.¹

What are the risks of investing?

Risk indicator for Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

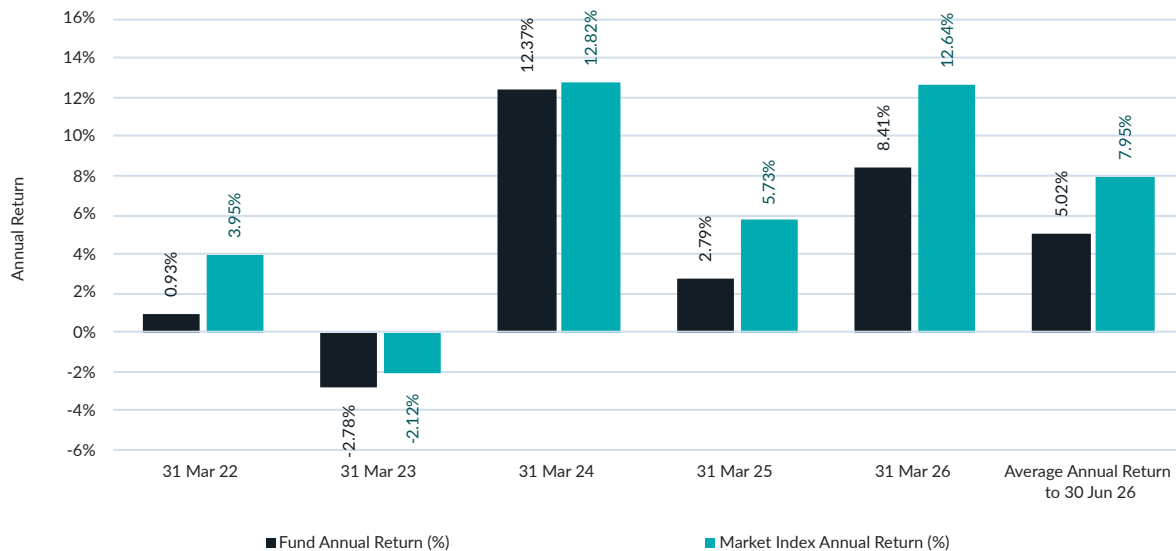

How has the fund performed?

EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Jane had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted but before tax of \$1,027 (that is 10.27% of her initial \$10,000). This gives Jane a total return after tax of \$1,020 for the year.

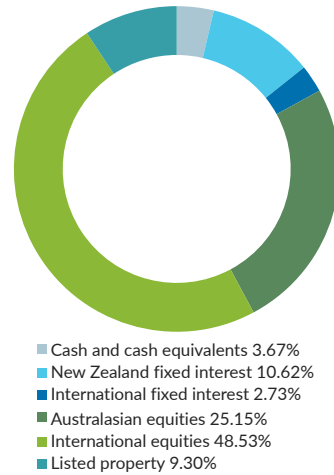

The top 10 investments make up 17.36% of the fund.

Foreign currency exposures associated with international fixed interest are hedged to the New Zealand dollar. We actively manage the fund's foreign currency exposures associated with international and Australian equities, and listed property. As at 30 June 2026, these exposures represented 59.82% of the value of the fund. After allowing for foreign currency hedges in place, 21.4% of the value of the fund was unhedged and exposed to foreign currency risk.

1. The composite benchmark for the Growth Fund is made up of the single asset class benchmarks weighted by the target asset allocation for the asset class. The single asset class benchmarks are the same as the benchmarks for the single asset class funds, and the benchmark for international fixed interest is the Bloomberg Global Aggregate Total Return Index 100% hedged to the New Zealand Dollar. The current weightings are as per the target investment mix referenced in this update under "what does this fund invest in?".
